Founded in 2008, Sierra Harvest is building a community that values and eats an abundance of fresh, local, seasonal food; training successful local farmers that are increasing sustainable food production; and creating equitable access to fresh, local, seasonal food. FARM TO SCHOOL: Sierra Harvest's Farm to School Program is currently in thirty-three Nevada County schools and reaches over 9,500 students including 96% of the K-8 students in Western Nevada County. Sierra Harvest connects each school with a local farm partner. This farmer hosts farm field trips at their farms, provides produce for a weekly produce stand at the school, and comes into the classroom to share farming stories and activities with the kids. Sierra Harvest also conducts monthly "Harvest of the Month" tastings of local, seasonal fruits and vegetables delivered to classrooms along with educator curriculum and a family newsletter. Sierra Harvest's "Tasting Days" brings guest chefs from around the county into hundreds of classrooms to cook simple, seasonal meals for 3,000 students. Pre and post-test survey data indicate that the students who participate in Sierra Harvest Farm to School programming try new fruits and veggies for the first time through Harvest of the Month, eat more of a fruit or veggie after trying it at school, and report that they shop directly from farmers more often.

TRANSFORMING SCHOOL FOOD THROUGH FARM TO SCHOOL: The Foothills Fresh meal program, which provides scratch cooked school meals to the Nevada City School district, proves that schools can serve fresh foods that kids will eat while earning

FARM INSTITUTE: The Farm Institute works alongside farmers and ranchers to support successful local farmers that are increasing sustainable food production in Nevada County. Farm Institute programs are designed to build the prosperity of ecologically sustainable producers, to increase the land in organic production, and to train more beginning farmers as the older generation of producers retires. The Sierra Harvest Agricultural skills classes train beginning farmers in regenerative agriculture production. Farm Biz, a six-week business skill-building course, brings small business professionals and educators to local farmers and ranchers. Sierra Harvest's Land Match program works to connect sustainable farmers and ranchers with locally available agricultural land. On-farm advising allows select Farm Biz graduates to enjoy consulting services by an experienced local farmer who assists them with customized business plans and strategies to improve their profitability. Sierra Harvest also offers an organic farming certification course. 20% of the organic farms in Nevada County became certified with our support. To date Sierra Harvest has trained 113 sustainable farmers, helped 6 farms certify organic, matched 17 farmers to low cost farm land and provided 2,330 hours of education to local farmers.

FARMER EVENTS: Sierra Harvest hosts community events promoting local food and farms that are attended by over 1,300 people each year. Farm potlucks feature different farms throughout the growing season, and Soup Night, which was cancelled due to COVID, typically features farm fresh soups and bread for family and community. Sierra Harvest's Sustainable Food and Farm conference is an annual regional conference designed to educate and connect the local and regional sustainable farming community. The Sustainable Food & Farm Conference serves 700 people, including 81 farmers who received scholarships to attend, and offers farm tours, hands-on workshops, and presentations from internationally recognized speakers, with breakout sessions for participants to ask questions and get advice. 85% of attendees reported that they were inspired to implement new sustainable techniques and strategies in their farm or garden.

Form 990, Part I, Line 6 - SIERRA HARVEST VOLUNTEERS: This year 238 generous volunteers worked over 2,260 hours to help Sierra Harvest accomplish their mission and vision. These volunteers built backyard gardens for low income families, taught cooking classes at 24 elementary schools and 4 high schools during Tasting Days, donated their time to help harvest fruit and vegetables that would otherwise go to waste from farms and home orchards and distributed them to those in need. They turned beds, planted starts, harvested, and weeded at our Food Love Educational Farm. They helped our staff produce over ten events that allowed our community to deeply engage in supporting the local food movement. Our board of directors helped create the next 5 year strategic plan and investment policy putting the plans in place to achieve long-term impact. Our future goals include 1) A community that values and eats an abundance of fresh, local, seasonal food; 2) Successful local farmers that are increasing sustainable food production; 3) Equitable access to fresh, local seasonal food; 4) A thriving, financially viable non-profit loved by its employees and the community.

Form 990, Part III, Line 2 - This year, Sierra Harvest launched an exciting new partnership with the Bear Yuba Land Trust, BriarPatch Food Coop, and the Tahoe Food Hub to support farmers and ranchers in achieving long-term land security in our region by protecting farmland forever. Our goal is to identify & protect farmland from development and subdivision, and give farmers and ranchers the land-access they need to invest in and build thriving agricultural businesses. Our first project is protecting the 37-acre property on Birchville Rd. in Nevada City, CA that Mountain Bounty Farm has been leasing. Together, the program partners have raised the money to purchase this property, put it into agricultural conservation easement and lease it back to farmers in perpetuity to produce local food for our community for generations. This will allow Mountain Bounty to make long-term infrastructure investments, and will allow the next generation of farmers the land security to succeed the original farm owner and manage the business in the future. We are currently in the process of identifying the next Forever Farm in our community!

revenue for their program. The program doubled participation over a two-year period, reduced food waste, dissipated the stigma about school lunch being for "poor kids" and increased revenue. Our work to improve school meals garnered a 2019 innovation award for the state of CA. The success of this pilot program ignited all nine school districts in Western Nevada County to sign a contract with Sierra Harvest and the Chef Ann Foundation to assess and implement a scratch cooked school meal program that could serve all 10,000 students.

SCHOOL_GARDEN_EDUCATION_THROUGH_FARM_TO_SCHOOL: Sierra Harvest provided 2 hours per week of garden education at 9 schools during the 19-20 school year. Through this program, 1,316 children participated in 10,658 hours of nutrition education, igniting their passions about where food comes from and setting the stage to expand the school garden program in the future. Sierra Harvest is engaging community partners and school districts to invest financially in each school garden to ensure that there isn't just one single source of funding or one incredible volunteer that allows the entire program to operate. This approach ensures future program sustainability and provides a sought after outdoor learning lab available to teachers in the age of hybrid educational models.
