FARM TO SCHOOL: Sierra Harvest's Farm to School Program is currently in 33 Nevada County schools & reaches over 9,500 students (97% of Western Nevada County's K-8 students). It connects students to fresh, local food through hands-on activities in school gardens, on farms, & in their cafeterias. Farm partners host farm field trips, provide 8 weeks of produce gobbled up by students on their school produce stand, & come to the classroom to share farming stories & activities with the kids. Farm to School also delivers monthly "Harvest of the Month" tastings of local fruits & vegetables to classrooms along with educator curriculum & a family newsletter. "Tasting Days" bring guest chefs into hundreds of classrooms to cook simple, seasonal meals with over 3,000 students. Foothills Fresh, scratch cooked meals for all, is changing the way students eat at school. Moving from frozen, processed foods heated & wrapped in plastic to fresh foods cooked from scratch is transforming nutritional opportunities for thousands of students. Salad bars & school gardens will soon be available on 11 school campuses. Sierra Harvest has successfully engaged school districts & community partners to invest financially in school gardens to ensure sustainability while creating an outdoor learning lab for teachers. Survey data show that participating students try new fruits & veggies for the first time through Harvest of the Month, eat more of a fruit or veggie after trying it at school, & shop directly from farmers more often.

FARM INSTITUTE: The Farm Institute works alongside farmers and ranchers to increase sustainable food production. Farm Institute programs build the prosperity of ecologically sustainable producers, increase the land in organic production, and train more beginning farmers as the older generation retires. Agricultural Skills Classes train beginning farmers in regenerative agriculture production. The six-week Farm Biz business skill-building course leaves participants with a concrete business plan and financial knowledge that is critical to running a viable farm business. The Land Match program connects sustainable farmers and ranchers with local agricultural land. To date, Sierra Harvest has trained 140 farmers, helped 10 farms certify organic, matched 25 farmers to low cost farm land, and provided 3,398 hours of education. Sierra Harvest hosts farm tours for the public and specifically invites institutional buyers to increase market opportunities for these farmers. Sierra Harvest's Sustainable Food and Farm conference is an annual regional conference designed to educate and connect the local and regional sustainable farming community. The Conference went virtual in 2021 in collaboration with Ecofarm. Participants engaged in workshops from internationally recognized speakers, with breakout sessions to ask questions and get advice. 77% of participating farmers/ranchers learned information that will contribute to their financial viability.

FOOD LOVE EDUCATIONAL FARM: Sierra Harvest's Food Love Farm is devoted to promoting nutrition education, food security, and community involvement in growing, harvesting, eating, and celebrating fresh food. The farm hosts experiential field trips, a summer camp, service projects, U-pick/Farm stand, and community volunteer days. This year the Food Love Farm provided 1,260 hours of hands-on farm education through farm school and summer camp to 670 community members. In 2020, the farm educators adapted their model to offer a CSA (Community Supported Agriculture) subscription to 10 families that received a box of weekly produce and fresh flowers and herbs.

Form 990, Part I, Line 6 - SIERRA HARVEST VOLUNTEERS: This year 152 generous volunteers worked over 1,900 hours to help Sierra Harvest accomplish their mission and vision. These volunteers built backyard gardens for low income families, donated their time to help harvest fruit and vegetables that would otherwise go to waste from farms and home orchards and distributed them to those in need. They turned beds, planted starts, harvested, and weeded at our Food Love Educational Farm. They helped our staff adapt to a new online communication model via Zoom that allowed our community to deeply engage in supporting the local food movement.

Form 990, Part III, Line 2 - School food in Western Nevada County was long overdue for an overhaul. In 2020, nine Western Nevada County school districts and Sierra Harvest engaged the Chef Ann Foundation to improve the experience and quality of school meals, thus providing more children with the nutrition they need to support academic performance and physical, mental and social wellbeing. We began developing a unique, one-of-a-kind student nutrition program that moves past the outdated model of processed food that is frozen, reheated, and wrapped in plastic to a healthier, sustainable model featuring scratch cooked meals using local and regional foods. Foothills Fresh scratch cooked school meals for all provides meals, education, and long term health benefits for generations to come. This state of the art meal program will serve up to 10,000 students during and after school as well as summer feeding needs.

Form 990, Part III, Line 3 - Sierra Harvest adapted to the pandemic and made modifications to programs following Nevada County Public Health guidance. Farm to school activities were mostly limited to Harvest of the month tastings and school garden education. Farm potlucks were adapted to farm tours focused more on connecting producers and farmers, and our Farm Biz classes and Sustainable Food and Farm Conference went virtual in collaboration with Ecofarm.

| | <p>COMMUNITY FOOD ACCESS: The Sierra Gardens program enhances health and food access by supporting families and community organizations in growing fruits and vegetables; providing garden infrastructure plus two years of gardening and cooking classes, mentorship and starts. Since the program began, Sierra Harvest has supported 112 gardens and seen a significant reduction in participants that had to regularly skip a meal. 86% of the program participants include more fresh fruits and vegetables in their diets than before the program and, and 100% now spend more time outside. Additionally, in a country where 40% of food goes to waste, the Sierra Harvest Gold County Gleaning program harvests local organic produce that would otherwise be thrown out or composted. This produce is donated to Interfaith Food Ministry who distributes it to 11,000 individuals with minimal access to fresh, organic food. The NCFPC is a member of the California Food and Farming Network which allows them to weigh in on statewide food and farming policies that impact Nevada County.
